“A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BIDDER and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF STEEL CORE AND JACKET CUP FOR 5.56MM M855 BULLET UNDER IB# GA-BAC-2017-86”

WHEREAS, the Invitation to Bid (IB) for the supply and delivery of 3,400,000 pieces each of Steel Core and Jacket Cup for 5.56mm M855 Bullet for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to Php17,850,000.00 was published in The Manila Times on 20 October 2017 and posted at GA website, conspicuous places and at designated bulletin boards of the Government Arsenal and its Liaison Office in Camp General Emilio Aguinaldo, Quezon City from 20 to 26 October 2017;

WHEREAS, prior to the bid opening, two (2) prospective bidders, namely; JV of Gecar Machine Solutions, Inc. & Rashtriya Metal Industries Ltd. of India and Poongsan Corporation of South Korea, secured bid documents;

WHEREAS, during the submission and opening of bids on 24 November 2017, said bidders submitted their first and second envelope containing their technical and financial components;

WHEREAS, during the preliminary examination of the submitted documents, the GA BAC declared the JV of Gecar Machine Solutions, Inc. & Rashtriya Metal Industries Ltd. of India as ineligible to bid due to incorrect declaration of authority to verify the submitted documents as stated on its Omnibus Sworn Statement (para. e); while the ones submitted by Poongsan Corporation were all rated “passed”;

WHEREAS, as a result, the GA TWG recommended to the GA BAC the declaration of Poongsan Corporation as the Single Calculated Bidder in the amount of Php16,476,400.00, pursuant to approved Resolution No. GA-BAC-PB-2017-170 dated 27 November 2017;

WHEREAS, having passed the post qualification, Poongsan Corporation was evaluated as post qualified to undertake the supply and delivery of Steel Core and Jacket Cup for 5.56mm M855 Bullet;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the GA BAC approves and adopts the recommendation of the GA TWG to declare Poongsan Corporation of South Korea as the SINGLE CALCULATED RESPONSIVE BIDDER (SCRB) and recommends to the Director, GA the issuance of Notice of Award in favor of Poongsan Corporation for the supply and delivery of 3,400,000 pieces each of Steel Core and Jacket Cup for 5.56mm M855 Bullet in the amount of Php16,476,400.00 under IB No. GA-BAC-2017-86;
