TO ALL MEN BY THESE PRESENTS:

THIS AGREEMENT made and entered into this MAR 13 2018 of _____, 2018 in the BALANGA CITY, BATAAN, Philippines, by and between:

GOVERNMENT ARSENAL, a government bureau under the Department of National Defense, with office address at Camp General Antonio Luna, Lamao, Limay, Bataan, represented by its Director, **DANIEL R. CASABAR JR.**, hereunder referred to as **FIRST PARTY**;

CHEMETALL PHILIPPINES CO. LTD. INC., a business entity organized and existing under Philippine laws, with office address at W-12 Veterans Road, Veterans Center, Taguig City, Philippines represented herein by **MR. CHRISTOPHER A. REAL**, who is duly authorized to enter into this Agreement, and hereinafter referred to as **SECOND PARTY**;

WITNESSETH

Whereas, the **FIRST PARTY** facilitated the procurement of 550 liters Degreaser for Quenched Metallic Links ARDROX 5503 by way of Direct Contracting under GA-BAC-DC-18-02;

Whereas, the **SECOND PARTY** has signified interest to supply the aforementioned item for a consideration of **ONE HUNDRED NINETY FIVE THOUSAND TWO HUNDRED FIFTY PESOS (PhP195,250.00.)**

Whereas, the **SECOND PARTY** has the capacity to supply the aforementioned item after it has complied with all of the requirements and specifications set forth by the former;


Now therefore, for and in consideration of the foregoing premises and the mutual covenants hereafter set forth, the **PARTIES** agree as follows:

 - a. Signed General Conditions;
 - b. Price Proposal submitted by the Supplier;
 - c. Purchase Order;
 - d. Certification of Exclusive Distributorship and Authorization for the local supplier; and
 - e. PhilGEPS Certificate or Registration Number
3. The **FIRST PARTY** hereby agreed to pay the **SECOND PARTY** the contract price in the manner prescribed by the contract in consideration for the delivery and acceptance of the items being prescribed.
4. This contract is subject to the provisions of Republic Act No. 9184 and its Revised Implementing Rules and Regulations.


