“A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF 7.62MM TRACER CARTRIDGE UNDER IB# GA-BAC-2019DP-05”

WHEREAS, the Invitation to Bid (IB) for the Procurement of 590,000rds 7.62mm Tracer Cartridge for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to Php30,090,000.00 was published in the Manila Times on 12 October 2018 and posted in the PhilGEPs, the GA Website and in conspicuous places at the GA premises from 12 to 19 October 2018;

WHEREAS, prior to the bid opening, only Poongsan Corporation of South Korea secured bidding documents and joined the bidding;

WHEREAS, during the submission and opening of bids on 07 November 2018, said bidder submitted its eligibility & technical and financial proposals which were all rated “passed”;

WHEREAS, tabulated below is the result of the opening of the financial proposal:

WHEREAS, from the above result the GA BAC TWG I recommended to the GA BAC the declaration of Poongsan Corporation as the Single Calculated Bidder (SCB) and the conduct of its post-qualification pursuant to approved Resolution No. GA-BAC-PB-2018-096 dated 12 November 2018;

WHEREAS, the result of the post-qualification to Poongsan Corporation conducted on September 2018 by the DND-BAC PQ Team headed by Dir Dinna Anna Lee L. Cartujano, was adopted on this procurement project;

WHEREAS, after further verification of the documents and evaluation on the technical capability, the GA BAC TWG I recommended Poongsan Corporation as qualified to undertake the supply and delivery of 590,000rds 7.62mm Tracer Cartridge;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the GA BAC approves and adopts the recommendation of the GA BAC TWG I to declare Pongsan Corporation of South Korea as the SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) and recommend to the Director, GA the issuance of Notice of Award in its favor for the procurement of 590,000rds 7.62mm Tracer Cartridge in the amount of Php25,311,000.00 under IB Nr. GA-BAC-2019DP-05.
