**WHEREAS**, the Invitation to Bid (IB) for the Procurement of Carton Boxes for the Government Arsenal (GA), with an Approved Budget for the Contract (ABC) amounting to a total of PhP2,140,681.70 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 01 – 08 April 2019;

**WHEREAS**, Advancekonek Corp's was declared as the Single Calculated Bid (SCB) in the total amount of PhP2,138,137.00, and the conduct of post-qualification pursuant to approved Resolution No. GA-BAC-PB-2019-059 dated 30 April 2019;
