“RESOLUTION DECLARING THE SINGLE / LOWEST CALCULATED RESPONSIVE BIDDERS and RECOMMENDING THE ISSUANCE OF NOTICES OF AWARD FOR THE PROCUREMENT OF SAFETY SUPPLIES AND RESPIRATOR UNDER IB# GA-BAC-2018-IA-07”

WHEREAS, the Invitation to Bid (IB) for the Procurement of Safety Supplies and Respirator for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to PhP6,021,200.00 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 18 to 24 April 2018;

WHEREAS, prior to the bid opening, five (5) prospective bidders namely: Gibson’s Shoe Factory, Inc., Oliveros Protective Equipment & Maritime Supplies, Up-Town Industrial Sales, Inc., King’s Safetynet Inc., and Mendo Enterprises secured bidding documents;

WHEREAS, during the submission and opening of bids on 8 May 2018, said bidders submitted their eligibility and technical components, however, only Gibson’s Shoe Factory, Inc., Up-Town Industrial Sales, Inc., and Oliveros Protective Equipment & Maritime Supplies were declared eligible to bid, while Mendo Enterprises and King’s Safetynet Inc. were declared ineligible to bid for failure to comply with the SLCC computation and Omnibus Sworn Statement, respectively;

WHEREAS, as a result of the bidding, following were declared as the Single / Lowest Calculated Bids, as per Resolution No. GA-BAC-PB-2018-032 dated 23 May 2018:


