**WHEREAS**, the Invitation to Bid (IB) for the Procurement of 74 LI Fabrication Supplies for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to PhP1,716,200.00 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 24 to 30 April 2018;

**WHEREAS**, prior to the submission and opening of bids, only EGM Industrial Sales secured bidding documents;

**WHEREAS**, during the submission and opening of bids on 15 May 2018, EGM Industrial Sales submitted its eligibility & technical and financial proposals, which were all rated “passed”;

**WHEREAS**, the bids of EGM Industrial Sales for 48 LI in the amount of PhP849,400.00 were declared as the Single Calculated Bids, as per Resolution No. GA-BAC-PB-2018-030 dated 18 May 2018;

**WHEREAS**, after verification of the documents and evaluation on the technical capabilities, the GA-TWG III recommended EGM Industrial Sales as qualified to undertake the supply and delivery of 48 LI Fabrication Supplies;

**WHEREAS**, We, the members of GA Bids and Awards Committee, resolve as it is hereby **RESOLVED** to adopt the recommendation of the GA TWG III to declare EGM Industrial Sales as the Single Calculated Responsive Bidder in the amount of PhP849,400.00 under IB# GA-BAC-2018-IA-10;

**NOW THEREFORE**, the GA BAC recommends to the Director, GA, the approval and issuance of Notice of Award in favor of EGM Industrial Sales for the Procurement of 48 LI Fabrication Supplies in the amount of PhP849,400.00;
