"RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF TOOLS AND DIES FOR M855 BULLET ASSEMBLY UNDER IB# GA-BAC-2018C-IA-24"

WHEREAS, the Invitation to Bid (IB) for the Procurement of one (1) lot Tools and Dies for M855 Bullet Assembly for the Government Arsenal (GA), with a total Approved Budget for the Contract (ABC) amounting to PhP1,400,000.00 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 25 June to 17 July 2019;

WHEREAS, prior to submission and opening of bids, three (3) prospective bidders namely: NSB Engineering Design and Fabrication, ALCRO Electronics, Inc. and Gecar Machine Solutions, Inc. secured bidding documents;

WHEREAS, during the submission and opening of bids on 17 July 2019, all bidders submitted their eligibility & technical and financial proposals, which were all rated "passed";

\*WHEREAS, shown below is the result of the opening of bids and the bid evaluation of the GA BAC TWG III:

WHEREAS, the bid of ALCRO Electronics, Inc. in the amount of PhP900,844.00 was declared as the Lowest Calculated Bid, per Resolution No. GA-BAC-PB-2019-082 dated 23 July 2019;

\*WHEREAS, after further verification of the documents and evaluation of the technical capability, the GA BAC TWG III recommended the declaration of ALCRO Electronics, Inc. as post-qualified and as the Lowest Calculated and Responsive Bidder (LCRB) to undertake the supply and delivery of one (1) lot Tools and Dies for M855 Bullet Assembly;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the GA BAC approves and adopts the recommendation of the GA BAC TWG III to declare ALCRO Electronics, Inc. as the LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) and recommends to the Director, GA the issuance of Notice of Award for the procurement of one (1) lot Tools and Dies for M855 Bullet Assembly in the total amount of PhP900,844.00 under IB No. GA-BAC-2018C-IA-24;
