“RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF PRODUCTION MACHINE PARTS UNDER IB# GA-BAC-2019-IA-20”

WHEREAS, the Procurement through Public Competitive Bidding of 32LI Production Machine Parts for the Government Arsenal (GA), with a total Approved Budget for the Contract (ABC) amounting to Php3,426,130.00 was programmed in the FY 2019 Annual Procurement Plan under Repair and Maintenance of Equipment – CUP Equipment (Page 1-B, B.1);

WHEREAS, its Invitation to Bid (IB) was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 07.– 14 September 2019;

WHEREAS, prior to submission and opening of bids, only Techline, Inc. secured bidding document;

WHEREAS, during the bid opening, the GA BAC, through the TWG III, examined the bidding requirements submitted by Techline, Inc. which were rated “passed” and Techline, Inc. was declared as eligible to bid;

WHEREAS, shown below is the result of the opening of bids and the bid evaluation of the GA TWG III:

WHEREAS, the bid of Techline, Inc. for 3LI only in the amount of Php750,000.00 was declared as the Single Calculated Bid, per Resolution No. GA-BAC-PB-2019-102 dated 02 October 2019;

WHEREAS, after further verification of the documents and evaluation of the technical capability, the GA TWG III recommended the declaration of Techline, Inc. as post-qualified and as the Single Calculated and Responsive Bidder (SCRB) to undertake the supply and delivery of 3LI Production Machine Parts;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the GA BAC approves and adopts the recommendation of the GA TWG III to declare Techline, Inc. as the SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) and recommends to the Director, GA the issuance of Notice of Award for the procurement of 3LI Production Machine Parts in the total amount of Php750,000.00 under IB No. GA-BAC-2019-IA-20;
