**“RESOLUTION DECLARING THE SINGLE CALCULATED BIDDER FOR LOT II (EXTENSION OF PRE-FILTER TANK AT WATER INTAKE) and RECOMMENDING THE CONDUCT OF POST-QUALIFICATION, AND DECLARING A FAILURE OF BIDDING FOR LOT I (RE-ROOFING AND RE-PAINTING OF CBD CHEMICAL WAREHOUSE) and THE CONDUCT OF RE-BIDDING FOR THE PROCUREMENT OF INFRASTRUCTURE PROJECTS UNDER IB # GA-BAC-2018-IP-03”**

**WHEREAS**, the Invitation to Bid (IB) for the Procurement of Infrastructure Projects by the Government Arsenal (GA), with a total Approved Budget for the Contract (ABC) amounting to Php2,030,249.00 consisting of two (2) lots was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 11 to 18 September 2018;

**WHEREAS**, prior to the bid opening, Mecon Systems Service and Maintenance Products and Five A Construction secured bidding documents;

**WHEREAS**, during the submission and opening of bids on 3 October 2018, said bidders submitted their eligibility and technical components, however, only Five A Construction was rated “passed” and declared eligible to bid since Mecon Systems Service and Maintenance Products was declared “ineligible” for failure to submit Single Largest Completed Contract (SLCC);

**WHEREAS**, Mecon Systems Service and Maintenance Products submitted its Motion for Reconsideration dated 5 October 2018 which the BAC denied per its letter on 10 October 2018;

**WHEREAS**, tabulated below is the result of the opening of the Financial Proposal:

**WHEREAS**, from the above tabulation, the GA TWG II recommended to the GA BAC the declaration of Five A Construction as the Single Calculated Bidder for Lot II (Extension of Pre-Filter Tank at Water Intake) and the conduct of its post-qualification;

**NOW THEREFORE, BE IT RESOLVED**, as it is hereby resolved that the GA BAC declares Five A Construction as the Single Calculated Bidder for Lot II in the amount of PhP1,207,699.00 and recommend to the Director, GA, the approval of the conduct of its post-qualification to determine responsiveness of its bid for the Extension of Pre-Filter Tank at Water Intake under IB # GA-BAC-2018-IP-03;

**RESOLVED FURTHER**, that the GA-BAC declares a failure of bidding for Lot I (Re-roofing and Re-painting of CBD Chemical Warehouse) in the amount of PhP815,821.00, since no bid was received, as per Section 35.1(a) of the IRR of RA 9184 and recommend to the Director, GA, the conduct of re-bidding after the PLD, in coordination with the end-user, conducts a mandatory review and evaluation of the terms, conditions, and specifications in the bidding documents, including its cost estimates (Section 35.2);


