**“RESOLUTION DECLARING THE SINGLE / LOWEST CALCULATED RESPONSIVE BIDDERS and RECOMMENDING THE ISSUANCE OF NOTICES OF AWARD FOR THE PROCUREMENT OF FABRICATION SUPPLIES UNDER IB# GA-BAC-2018-IA-01”**

**WHEREAS**, the Invitation to Bid (IB) for the Procurement of Fabrication Supplies for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to PhP14,003,100.00 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 22 - 28 January 2018;

**WHEREAS**, prior to the bid opening, four (4) prospective bidders namely: Atarashii Technologies International, Up-Town Industrial Sales, Inc., Techline Machine Tools, Inc. and Gecar Machine Solutions, Inc. secured bidding documents;

**WHEREAS**, during the submission and opening of bids on 12 February 2018, said bidders submitted their eligibility & technical and financial proposals, which were all rated “passed”;

**WHEREAS**, the bids of Atarashii Technologies International in the amount of PhP2,166,731.50 for 17 LI, Up-Town Industrial Sales, Inc. in the amount of PhP708,375.00 for 55 LI, Techline Machine Tools, Inc. in the amount of PhP4,468,082.00 for 55 LI and Gecar Machine Solutions, Inc. in the amount of PhP745,954.00 for 22 LI were declared as the Single / Lowest Calculated Bids for the specific line items, as per Resolution No. GA-BAC-PB-2018-004 dated 15 February 2018;

**WHEREAS**, after verification of the documents and evaluation on the technical capability, the GA-TWG III recommended the above cited bidders as qualified to undertake the Procurement of Fabrication Supplies;

**WHEREAS**, We, the members of GA Bids and Awards Committee, resolve as it is hereby **RESOLVED** to approve and adopt the recommendation of the GA TWG III to declare Atarashii Technologies International, Up-Town Industrial Sales, Inc., Techline Machine Tools, Inc. and Gecar Machine Solutions, Inc. as the Single / Lowest Calculated Responsive Bidders in the amounts of PhP2,166,731.50, PhP708,375.00, PhP4,468,082.00 and PhP745,954.00, respectively under IB# GA-BAC-2018-IA-01;

**NOW THEREFORE**, the GA BAC recommends to the Director, GA, the issuance of Notices of Award in favor of Atarashii Technologies International, Up-Town Industrial Sales, Inc., Techline Machine Tools, Inc. and Gecar Machine Solutions, Inc. for the Procurement of Fabrication Supplies in the amounts of PhP2,166,731.50, PhP708,375.00, PhP4,468,082.00 and PhP745,954.00, respectively;
