“RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BIDDER and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF VINYL TAPE AND THERMAL TRANSFER PRINTER RIBBON UNDER IB# GA-BAC-2018-IA-02”

WHEREAS, the Invitation to Bid (IB) for the Procurement of Vinyl Tape and Thermal Transfer Printer Ribbon for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to PhP10,912,000.00 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 5 - 11 February 2018;

WHEREAS, prior to the bid opening, three (3) prospective bidders namely: Top-Rigid Industrial Safety Supply, Inc., Mendo Enterprises and Niclao Trading secured bidding documents;

WHEREAS, during the submission and opening of bids on 26 February 2018, said bidders submitted their eligibility & technical and financial proposals, which were all rated “passed”;

WHEREAS, the bid of Top-Rigid Industrial Safety Supply, Inc. in the amount of PhP8,265,540.00 was declared as the Lowest Calculated Bid, as per Resolution No. GA-BAC-PB-2018-006 dated 28 February 2018;

WHEREAS, after verification of the documents and evaluation on the technical capability, the GA-TWG III recommended the Top-Rigid Industrial Safety Supply, Inc. as qualified to undertake the Procurement of Vinyl Tape and Thermal Transfer Printer Ribbon;

WHEREAS, as per Section 34.4 of the Revised IRR of RA 9184, if the BAC determines that the bidder with the Lowest Calculated Bid (LCB) passes all the criteria for post-qualification, it shall declare the said bid as the LCRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, **whichever is lower**.

WHEREAS, We, the members of GA Bids and Awards Committee, resolve as it is hereby **RESOLVED** to approve and adopt the recommendation of the GA TWG III to declare Top-Rigid Industrial Safety Supply, Inc. as the Lowest Calculated Responsive Bidder in the amount of PhP8,220,200.00 being the submitted bid price under IB# GA-BAC-2018-IA-02;


