**RESOLUTION No. GA-BAC-PB-2018-013

**“A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BIDDER and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF 7.62MM TRACER CARTRIDGE UNDER IB# GA-BAC-2018DP-02”**

**WHEREAS**, the Invitation to Bid (IB) for the Procurement of 422,000rds 7.62mm Tracer Cartridge for the Government Arsenal (GA), with an Approved Budget for the Contract (ABC) amounting to PhP21,100,000.00 was published in the Manila Times on 19 January 2018 and posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 19 to 25 January 2018;

**WHEREAS**, prior to the bid opening, two (2) prospective bidders namely; Companhia Brasileira De Cartuchos (CBC) of Brazil and Poongsan Corporation of South Korea secured bidding documents;

**WHEREAS**, during the submission and opening of bids on 23 February 2018, CBC of Brazil and Poongsan Corporation submitted their first and second envelopes containing the technical and financial components of the bid, respectively, which were all rated “passed”;

**WHEREAS**, tabulated below is the result of the opening of the financial proposals:

**WHEREAS**, as shown above, both bids were within the ABC, but CBC of Brazil tendered a lower bid;

**WHEREAS**, the GA BAC TWG recommended to the GA BAC the declaration of CBC of Brazil as the Lowest Calculated Bidder in the amount of PhP20,137,840.00 and the conduct of its Post Qualification;

**WHEREAS**, after verification of the documents and evaluation on the technical capability, the GA BAC TWG recommended CBC of Brazil as qualified to undertake the supply and delivery of 422,000rds 7.62mm Tracer Cartridge;

**NOW THEREFORE, BE IT RESOLVED**, as it is hereby resolved, that the GA BAC approves and adopts the recommendation of the GA BAC TWG to declare Companhia Brasileira de Cartuchos (CBC) of Brazil as the LOWEST CALCULATED RESPONSIVE BIDDER (LCRB) and recommends to the Director, GA the issuance of Notice of Award in its favor for the procurement of 422,000rds 7.62mm Tracer Cartridge in the amount of PhP20,137,840.00 under IB Nr. GA-BAC-2018DP-02;
