“RESOLUTION DECLARING A FAILURE OF BIDDING AND RECOMMENDING THE CONDUCT OF RE-BIDDING FOR THE PROCUREMENT OF 5.56MM PRIMER AND 7.62MM M13 LINKS UNDER IB NR. GA-BAC-2018DP-13-TF”

WHEREAS, the Invitation to Bid (IB) for the Procurement of 3,000,000pcs 5.56mm Primer and 2,000,000pcs 7.62mm M13 Links consisting of two (2) lots (Lot I – 5.56mm Primer and Lot II – 7.62mm M13 Links) for the Government Arsenal (GA), with an Approved Budget for the Contract (ABC) amounting to PhP17,300,000.00 was published in the Manila Times on 08 June 2018 and posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 08 to 14 June 2018;

WHEREAS, during the submission and opening of bids on 29 June 2018, no bidder responded;

WHEREAS, the GA BAC TWG I recommended to the GA BAC the declaration of a failure of bidding since no bid was received and the conduct of re-bidding after the PLD, in coordination with the end-user, conducts a mandatory review of the specifications of the items and re-evaluation of the terms and conditions in the bidding documents, including its cost estimates (Section 35.1(a) and Section 35.2 of the IRR of RA 9184);

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved that the GA BAC declares a FAILURE OF BIDDING since no bid was received and recommends to the Director, GA the conduct of re-bidding after the PLD, in coordination with the end-user, conducts a mandatory review of the specifications and re-evaluation of the terms and conditions in the bidding documents, including its cost estimates for the Procurement of 3,000,000pcs 5.56mm Primer and 2,000,000pcs 7.62mm M13 Links under IB Nr GA-BAC-2018DP-13-TF.


