“RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT PROJECT - REPAIR WORKS AT CAPD UNDER IB# GA-BAC-2018-IP-02”

WHEREAS, the Invitation to Bid (IB) for the Procurement Project - Repair Works at CAPD for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to PhP1,186,313.00 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 20 to 27 July 2018;

WHEREAS, prior to the bid opening, Mecon Systems Service and Maintenance Products, DM Madarang Construction and RZ Tigas Construction and Trading secured bidding documents;

WHEREAS, during the submission and opening of bids on 13 August 2018, aforementioned bidders submitted their eligibility & technical and financial proposals, which were all rated “passed” and declared eligible to bid;

WHEREAS, the bid of RZ Tigas Construction and Trading for the Repair Works at CAPD in the amount of PhP984,788.00 was declared as the Lowest Calculated Bid, as per Resolution No. GA-BAC-PB-2018-067 dated 28 August 2018;

WHEREAS, after verification of the documents and evaluation on the technical capabilities, the GA-TWG II recommended RZ Tigas Construction and Trading as qualified to undertake the Procurement Project – Repair Works at CAPD;

WHEREAS, We, the members of GA Bids and Awards Committee, resolve as it is hereby **RESOLVED** to adopt the recommendation of the GA TWG II to declare RZ Tigas Construction and Trading as the Lowest Calculated and Responsive Bidder in the amount of PhP984,788.00 under IB# GA-BAC-2018-IP-02;

NOW THEREFORE, the GA BAC recommends to the Director, GA, the approval and issuance of Notice of Award in favor of RZ Tigas Construction and Trading for the Procurement Project – Repair Works at CAPD in the amount of PhP984,788.00;
