

Contract Agreement

THIS AGREEMENT made the \_\_\_\_\_ day of SEP 13 2018 between **GOVERNMENT ARSENAL**, Camp General Antonio Luna, Limay, Bataan of the Philippines (hereinafter called "the Entity") of the one part and the **Joint Venture Partnership of DAYAL SOLDERS and GECAR MACHINE SOLUTIONS, INC.** of No. 17 Mars Street, Congressional Subdivision II, Tandang Sora, Quezon City (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Procurement of 63,000 kgs Lead Wire for Cal .45, IB # GA BAC 2018DP-03-R** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWELVE MILLION ONE HUNDRED SIXTY TWO THOUSAND ONE HUNDRED FIFTY PESOS (PhP12,162,150.00)** only (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) Bid Form and the Price Schedule submitted by the Bidder;
  - (b) Schedule of Requirements;
  - (c) Technical Specifications;
  - (d) General Conditions of Contract;
  - (e) Special Conditions of Contract;
  - (f) Entity's Notification of Award; and
  - (g) Supplemental Bulletin
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

IN WITNESS whereof the parties thereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first before written.






