**RESOLUTION No. GA-BAC-PB-2018-127

“A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF 5.56MM M27 LINKS UNDER IB# GA-BAC-2018DP-19-R”

WHEREAS, the Invitation to Bid (IB) for the Procurement of 6,500,000pcs 5.56mm M27 Links for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to PhP29,250,000.00 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 13 to 20 November 2018;

WHEREAS, prior to the bid opening, two (2) prospective bidders namely; Holistic Marketing Services Communication Firm Corp. and Gecar Machine Solutions, Inc. secured bidding documents;

WHEREAS, during the submission and opening of bids on 05 December 2018, said bidders submitted their eligibility and technical components;

WHEREAS, Gecar Machine Solutions, Inc. JV with POB Drustvos Organicenom Odogovornoscu Za Prizvodnju, Trgovinu I Usluge (POB d.o.o.) documents were rated “passed”, while Holistic Marketing Services Communication Firm Corp. JV with BUD Enterprises was declared ineligible to bid for failure to submit an original Joint Venture Agreement as required in ITB Clause 20.3 of the Bidding Documents;

WHEREAS, tabulated below is the result of the opening of the financial proposal of the lone qualified bidder:

WHEREAS, from the above result, the GA TWG I recommended to the GA BAC the declaration of Gecar Machine Solutions, Inc. JV with POB d.o.o. as the Single Calculated Bidder (SCB) and the conduct of its post-qualification pursuant to approved Resolution No. GA-BAC-PB-2018-116 dated 06 December 2018;


WHEREAS, based on the domestic results of the post-qualification of Gecar Machine Solutions, Inc. and foreign post-qualification of POB d.o.o. conducted on December 10 – 21, 2018, the PQ Team headed by Atty. Abigail C. Gabriel recommended the declaration of Gecar Machine Solutions, Inc. JV with POB d.o.o. as post-qualified and as the Single Calculated Responsive Bidder (SCRB), hence, qualified to undertake the supply and delivery of 6,500,000pcs 5.56mm M27 Links;



JV with POB d.o.o. as post-qualified and SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) and recommends to the Director, GA the issuance of Notice of Award in its favor for the procurement of 6,500,000pcs 5.56mm M27 Links in the amount of PHP16,185,000.00 under IB Nr. GA-BAC-2018DP-19-R;
