“A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BIDDER and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF CARTON BOXES UNDER IB# GA-BAC-2018DP-07” ✓

WHEREAS, the Invitation to Bid (IB) for the Procurement of Carton Boxes for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to PhP2,358,000.00 was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 26 April to 02 May 2018; ✓

WHEREAS, prior to the bid opening, three (3) prospective bidders namely; L. Victoria Trading, 168 Paragon International and Solid Printing Corporation secured bidding documents; ✓

WHEREAS, during the submission and opening of bids on 16 May 2018, only L. Victoria Trading and 168 Paragon International submitted its eligibility and technical components;

WHEREAS, 168 Paragon International documents were rated “passed”, while L. Victoria Trading was disqualified for failure to comply with the Single Largest Completed Contract (SLCC); ✓

WHEREAS, shown below is the result of the opening of the financial proposal of the lone qualified bidder:

WHEREAS, from the above result the GA BAC TWG I recommended to the GA BAC the declaration of 168 Paragon International as the Single Calculated Bidder and the conduct of its post-qualification pursuant to approved Resolution No. GA-BAC-PB-2018-033 dated 25 May 2018;

WHEREAS, after verification of the documents and evaluation on the technical capability, the GA BAC TWG I recommended 168 Paragon International General Contractor & Equipment as qualified to undertake the supply and delivery of Carton Boxes; ✓


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the GA BAC approves and adopts the recommendation of the GA BAC TWG I to declare 168 Paragon International General Contractor & Equipment as the SINGLE CALCULATED RESPONSIVE BIDDER (SCRB) and recommends to the Director, GA the issuance of Notice of Award in its favor for the procurement of Carton Boxes in the amount of Php1,844,790.00 under IB Nr. GA-BAC-2018DP-07;
