**“A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BIDDERS (SCRBS) and RECOMMENDING THE ISSUANCE OF NOTICES OF AWARD FOR THE PROCUREMENT OF PLASTIC CRATE AND METAL AMMUNITION BOX UNDER IB# GA-BAC-2018DP-10”**

**WHEREAS**, the Invitation to Bid (IB) for the Procurement of 15,200pcs Plastic Crate and 25,200pcs Metal Ammunition Box consisting of two (2) lots (Lot I – Plastic Crate and Lot II – Metal Ammunition Box) for the Government Arsenal (GA), with an Approved Budget for the Contract (ABC) amounting to Php21,763,000.00 was published in the Manila Times on 21 May 2018 and posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 21 to 27 May 2018;

**WHEREAS**, prior to the bid opening, three (3) prospective bidders namely; Far East Industrial Supply & Co., Inc., Plastimer Industrial Corporation and Gecar Machine Solutions, Inc. secured bidding documents;

**WHEREAS**, during the submission and opening of bids on 13 June 2018, only FEISCO and Plastimer Industrial Corporation submitted its eligibility & technical and financial proposals which were all rated “passed”;

**WHEREAS**, tabulated below is the result of the opening of the financial proposals:

**WHEREAS**, from the above tabulation, the GA BAC TWG I recommended to the GA BAC the declaration of Plastimer Industrial Corporation as the Single Calculated Bidder (SCB) for Lot I – Plastic Crate and Far East Industrial Supply & Co., Inc. (FEISCO) as the Single Calculated Bidder (SCB) for Lot II – Metal Ammunition Box; and the conduct of their post-qualification pursuant to approved Resolution No. GA-BAC-PB-2018-047 dated 19 June 2018;

**WHEREAS**, after verification of the documents and evaluation on the technical capability, the GA BAC TWG I recommended the both bidders as qualified to undertake the supply and delivery of Plastic Crate (Lot I) and Metal Ammunition Box (Lot II);


**NOW THEREFORE, BE IT RESOLVED**, as it is hereby resolved, that the GA BAC approves and adopts the recommendation of the GA BAC TWG I to declare Plastimer Industrial Corporation and FEISCO as the SINGLE CALCULATED RESPONSIVE BIDDERS (SCRBs) and recommends to the Director, GA the issuance of Notices of Award in its favor for the procurement of 15,200pcs Plastic Crate (Lot I) and 25,200pcs Metal Ammunition Box (Lot II) in the amounts of PhP5,433,000.00 and PhP16,203,600.00 respectively under IB Nr. GA-BAC-2018DP-10;


