“A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF SAFETY AND COMMUNICATION SUPPLIES UNDER IB# GA-BAC-2023-10”

WHEREAS, the Procurement of 70 LJ Safety and Communication Supplies for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to a total of PhP8,015,370.00 was programmed in the Government Arsenal's Annual Procurement Plan FY 2023 under General Administrative Services;

WHEREAS, the guidelines of Public Competitive Bidding were followed in accordance with the Revised IRR of RA 9184;

WHEREAS, the Invitation to Bid (IB) was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from March 8 to 14, 2023;

WHEREAS, pursuant to approved Resolution No. GA-BAC-PB-SCS-2023-02 dated 20 April 2023, Top-Rigid Industrial Safety Supply, Inc.'s bids for 22 line items in the total amount of PhP2,274,721.05 was declared as the Single Calculated Bids and directed the conduct of post-qualification of the said bidder;

WHEREAS, on the same resolution, a failure of bidding was declared for 48 line items due to reasons cited therein in the total amount of PhP2,691,695.00;

WHEREAS, upon validation and verification of the eligibility documents, technical capability and financial proposal, and upon acceptance of the submitted samples, the GA TWG recommended the declaration of Top-Rigid Industrial Safety Supply, Inc.'s bids as the Single Calculated & Responsive Bids and qualified to undertake the supply and delivery of Safety and Communication Supplies;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the GA BAC adopts the recommendations of the GA TWG and respectfully recommends to the Director, GA the approval of the following:

- a. Declaration of Top-Rigid Industrial Safety Supply, Inc. as post-qualified and its bids for 22 line items in the total amount of PhP2,274,721.05 as the Single Calculated and Responsive Bids; and
- b. Issuance of Notice of Award in favor of Top-Rigid Industrial Safety Supply, Inc. in the total amount of PhP2,274,721.05 for the Procurement of Safety and Communication Supplies under IB No. GA-BAC-2023-10;
