**“A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT OF CONSTRUCTION SUPPLIES AND MATERIALS UNDER IB# GA-BAC-2023-14”**

**WHEREAS**, the Procurement of 321 LI Construction Supplies and Materials for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to a total of PhP4,970,200.00 was programmed in the Government Arsenal’s Annual Procurement Plan FY 2023 under Maintenance of Facilities/In-house Repair Projects;

**WHEREAS**, the guidelines of Public Competitive Bidding were followed in accordance with the Revised IRR of RA 9184;

**WHEREAS**, the Invitation to Bid (IB) was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from February 16 to 22, 2023;

**WHEREAS**, the submission and opening bids was conducted on 09 March 2023 wherein Up-Town Industrial Sales, Inc. was the lone proponent;

**WHEREAS**, pursuant to approved Resolution No. GA-BAC-PB-CSM-2023-02 dated 15 March 2023, Up-Town Industrial Sales, Inc.’s bids for 192 line items in the total amount of PhP2,246,064.90 was declared as the Single Calculated Bids and directed the conduct of post-qualification of the said bidder;

**WHEREAS**, on the same resolution, a failure of bidding was declared for 129 line items due to reasons cited therein;

**WHEREAS**, upon validation and verification of the eligibility documents, technical capability and financial proposal, the GA TWG recommended the declaration of Up-Town Industrial Sales, Inc.’s bids as the Single Calculated & Responsive Bids and qualified to undertake the supply and delivery of Construction Supplies and Materials;

**NOW THEREFORE, BE IT RESOLVED**, as it is hereby resolved, that the GA BAC adopts the recommendations of the GA TWG and respectfully recommends to the Director, GA the approval of the following:

- a. Declaration of Up-Town Industrial Sales, Inc. as post-qualified and its bids for 192 line items in the total amount of PhP2,246,064.90 as the Single Calculated and Responsive Bids; and
- b. Issuance of Notice of Award in favor of Up-Town Industrial Sales, Inc. in the total amount of PhP2,246,064.90 for the Procurement of Construction Supplies and Materials under IB No. GA-BAC-2023-14;
