**RESOLUTION No. GA-BAC-PB-AC-2023-01,
05 April 2023**

“RESOLUTION DECLARING A FAILURE OF BIDDING and RECOMMENDING THE CONDUCT OF RE-BIDDING FOR THE PROCUREMENT OF ASSORTED CHEMICALS UNDER IB NO. GA-BAC-2023-16”

WHEREAS, the Procurement through Public Competitive Bidding of Assorted Chemicals for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to PhP1,453,775.00 was programmed in the Government Arsenal’s Annual Procurement Plan FY 2023;

WHEREAS, the Invitation to Bid was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 09 – 15 March 2023;

WHEREAS, prior to submission and opening of bids, Firstchem Technologies, Inc. secured bidding documents for the project;

WHEREAS, during the submission and opening of bids on 29 March 2023, the TWG examined the bidding requirements submitted by aforesaid bidder, shown below is the result;

Firstchem Technologies, Inc. WHEREAS, based on the grounds mentioned above, Firstchem Technologies, Inc. was declared as ineligible to bid. However, was allowed to submit a Motion for Reconsideration pursuant to Section 55 of the Revised IRR of RA9184;

WHEREAS, Firstchem Technologies, Inc. did not submit a Motion for Reconsideration;

WHEREAS, foregoing considered, the GA TWG recommended to the GA BAC the declaration of failure of bidding in the total amount of PhP1,453,775.00, since aforesaid bidder was declared as ineligible to bid, as per Section 35.1 of the IRR of RA 9184 and the conduct of re-bidding after mandatory review and re-evaluation of the terms and conditions in the bidding documents, including its cost estimates by the Planning and Logistics Division and the end-user (Section 35.2 of the Revised IRR of RA 9184);

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved that the GA BAC adopts the recommendation of GA TWG and recommends to the Director, GA the approval of the declaration of a FAILURE OF BIDDING since the lone bidder was declared as ineligible to bid and the conduct of re-bidding after mandatory review and evaluation of terms, conditions and specifications in the bidding documents, including its cost estimates by the Planning and Logistics Division, in coordination with the end-user, for the Procurement of Assorted Chemicals under IB # GA-BAC-2023-16.
