“A RESOLUTION RECOMMENDING THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE PROCUREMENT 7.62MM UNPRIMED CASE UNDER IB # GA-BAC-2023-32C”

WHEREAS, the Procurement of one (1) lot 7.62mm Unprimed Case (3,500,000 pcs) for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to PhP49,000,000.00 was programmed in GA's Annual Procurement Plan. Fund source is from the Continuing Appropriations FY 2022;

WHEREAS, pursuant to DA-Approved Resolution No. GA-BAC-762UC-2023-02 dated 21 June 2023, Arm Scor Global Defense, Inc. was declared as Single Calculated Bid (SCB) for one (1) lot 7.62mm Unprimed Case in the amount of PhP49,000,000.00;
