**“RESOLUTION RECOMMENDING THE DECLARATION OF FAILURE OF BIDDING AND THE CONDUCT OF RE-BIDDING FOR THE PROCUREMENT OF 5.56MM UNPRIMED BLANK CASE FOR ROSETTE CRIMPED TYPE UNDER IB # GA-BAC-2023-54-TF”**

**WHEREAS**, the Procurement of 5.56mm Unprimed Blank Case for Rosette Crimped Type for the Government Arsenal (GA) with a total Approved Budget for the Contract (ABC) amounting to a total of PhP25,500,000.00 was programmed in GA Annual Procurement Plan to be funded from the Inter-Agency Transfer of Funds;

**WHEREAS**, the Invitation to Bid (IB) was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 06 to 13 September 2023;

**WHEREAS**, prior to submission and opening of bids, only Armscor Global Defense Inc (AGDI) secured bidding documents;

**WHEREAS**, during the bid opening on 28 September 2023, said bidder submitted its proposal but was declared ineligible to bid since the submitted Compliance to Technical Specifications (Section VII of the Bidding Documents) was found not responsive in view of AGDI's compliance to both choices on Section 2. Gaging (Dimension)/Hardness. Per instruction, the bidder must state compliance to either of the following: 2.1 Use of Drawing No. ACB101-02 or 2.2 Use Manufacturer's Drawing;

**WHEREAS**, foregoing considered, the GA TWG recommended to the GA BAC the declaration of a FAILURE OF BIDDING for the Procurement of 5.56mm Unprimed Blank Case for Rosette Crimped Type since the lone proponent was declared as ineligible to bid, as per Section 35.1b of the Revised IRR of RA 9184, and the consequent conduct of re-bidding;

**NOW THEREFORE, BE IT RESOLVED**, as it is hereby resolved that the GA BAC recommends to the Director, GA the approval of the declaration of a FAILURE OF BIDDING since the lone bidder was declared ineligible and the conduct of re-bidding for the 5.56mm Unprimed Blank Case for Rosette Crimped Type under IB # GA-BAC-2023-54TF, following the provisions of Sec. 35 of the Revised IRR of RA 9184.


