“RESOLUTION DECLARING A FAILURE OF BIDDING and RECOMMENDING THE IMMEDIATE CONDUCT OF RE-BIDDING FOR THE PROCUREMENT PROJECT - TANK CLEANING OF 1 MILLION GALLON WATER RESERVOIR UNDER IB No. GA-BAC-2023-IP-38C-R”

WHEREAS, the Procurement Project - Tank Cleaning of 1 Million Gallon Water Reservoir for the Government Arsenal (GA) with total Approved Budget for the Contract (ABC) amounting to ~~Php~~5,990,000.00 was conducted by the GA BAC. Fund source is from the Continuing Appropriations for FY 2022;

WHEREAS, the guidelines of Public Bidding were followed in accordance with the Revised IRR of RA 9184;

WHEREAS, the Invitation to Bid (IB) was posted in the PhilGEPS, the GA Website and in conspicuous places at the GA premises from 26 July to 01 August 2023;

WHEREAS, prior to submission and opening of bids, two (2) prospective bidders, namely: Kenta Kogyo Corporation and AS Macha Construction & Trading secured bidding documents and submitted their bids;

WHEREAS, during the bid opening on 16 August 2023, the GA BAC, through the TWG, examined the submitted eligibility and technical components of both bidders wherein both of them were declared as ineligible to bid for failure to comply the following requirements:


WHEREAS, C, BAC informed the representatives of both bidders that they may file a Motion for Reconsideration (MR) within three (3) calendar days; however, both of them responded that they will no longer file an MR. The eligibility and technical documents, as well as the unopened financial components, of both ineligible bidders were re-sealed and returned back to its respective representatives;

WHEREAS, based on the foregoing, the GA TWG recommends to the GA BAC to declare a failure of bidding since both proponents were declared as ineligible to bid and the immediate conduct of re-bidding after mandatory review and evaluation of terms, conditions and specifications in the bidding documents, including its cost estimates by the Planning and Logistics Division, in coordination with the end-user;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved that the GA BAC recommends to the Director, GA the approval of the declaration of a FAILURE OF BIDDING since both proponents were declared as ineligible to bid and the immediate conduct of re-bidding after mandatory review and evaluation of terms, conditions and specifications in the bidding documents, including its cost estimates by the Planning and Logistics Division, in coordination with the end-user for the Procurement Project - Tank Cleaning of 1 Million Gallon Water Reservoir under IB No. GA-BAC-2023-IP-38C-R pursuant to Section 35.1b and Section 35.2 of RA 9184;
