"A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) and RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE FOR THE PROCUREMENT OF 5.56MM UNPRIMED CASE UNDER IB # GA-BAC-2023-51TF"

WHEREAS, the Procurement through Public Competitive Bidding of 5,000,000 pcs 5.56mm Unprimed Case with a total Approved Budget for the Contract (ABC) amounting to Php49,500,000.00 was conducted by the GA BAC. Fund Source is from GA Trust Fund;

WHEREAS, pursuant to Resolution No. GA-BAC-556MMMUC-2023-02, dated 30 August 2023, the financial proposal of Armscor Global Defense Inc amounting to Php47,250,000.00 was declared as the Single Calculated Bid (SCB) and directed the conduct of the post qualification (PQ) of the said bidder;

WHEREAS, upon validation and verification of the eligibility documents and technical capability of the proponent, the GA TWG recommended to the GA BAC the declaration of its tender as the Single Calculated and Responsive Bid (SCRB) and qualified to undertake the supply and delivery of 5,000,000 pcs 5.56mm Unprimed Case;
