RECONSTITUTION


1. Pursuant to Rule VIII of the Rules Implementing the Code of Conduct and Ethical Standards for Public Officials and Employees, as amended by CSC Resolution No. 06-0231 dated February 1, 2006 on the establishment of a standard review and compliance procedure for the review of SALN, the Review and Compliance Committee is hereby reconstituted effective upon approval to be composed of the following GA executives/personnel:

2. The functions of the Committee are as follows:

a) Evaluates the Statement of Assets, Liabilities and Net Worth Form (SALN) and Disclosure of Business Interests and Financial Connections submitted by GA personnel yearly to determine whether it was submitted on time, accomplished completely and proper in form; and

b) Interprets the provisions on review and compliance procedure in the filing of SALN to ensure conformity to set standards.
